Short Narrative Description of Teaching, Research and Service Interests.

I am interested in helping students understand and think critically about the representative democratic form of government in general, and the Constitution of the United States in particular. These are the methods by which we, as a self-governing people, purport to govern ourselves. It is the nature of self-governance that it relies utterly on the informed ability of each person to exercise his or her governing authority. None of us can fulfill that task if we do not understand the principles upon which the government was established, and why, and how the system is supposed to operate. We cannot even intelligently decide to reject that system and its values if we do not accurately understand their true nature and purpose.

My interest in the introductory class is to orient the students to the political world, the various forms of governance employed in it, and what governments do. To equip them, in short, with a vocabulary of politics so they can understand current events better, and go on to more advanced study. At the upper division, my goal is to arm students with accurate and in-depth information, and to help train them in critical thinking about that information so they can do their jobs in a free, self-governing society. I do not imagine any of my students doubts my belief in the essential worth of the Constitution's values, but I emphasize to them that they, as free people, are at liberty to accept or reject those values as they see fit, and to determine for themselves how well we are preserving those values, and how best to do that in the future. My job is not answer all those questions for them---I would not even if I could---but to help equip them with information and analytical skills so that they can answer them for themselves.

I do not do "research" in the academic sense; I produce no works of scholarship. But the field of Constitutional Law is constantly changing, and I am constantly reading and assessing the developments in the law in order to keep my classes current. My service work is focused on being the department's Undergraduate Advisor. I take this role very seriously. I know from my own experience, and my daughter's recent college experience, how valuable an informed and sympathetic advisor can be to an undergraduate. In addition, I value the work I do with the Undergraduate Committee. I think we have thoughtfully addressed the issues put before us, and it is the primary source of my interaction with other members of the faculty. This has improved my advising, and also my instruction of the introductory level course by making me more aware of the needs of the other members of the faculty

Undergraduate Student Mentoring:

As Undergraduate Advisor for the Department, I have informally mentored scores of majors and minors as they progressed towards their degrees. This also includes the many, many students whom I have advised and counseled during and after the process of applying to and attending law school.

Curriculum Development or Teaching Administrative Positions:

2005-date. Undergraduate Advisor. It is my job to advise majors and minors on completion of the department's requirements, to approve and classify transfers of courses from other colleges and universities, and to provide guidance and direction as requested as students make their way through the undergraduate process. I see hundreds of students every year in my office. I developed carbonless versions of the "Plan of Study for the Major/Minor" forms the department uses so that the student and I both had a record of our conversation, and the student's progress towards completion of the degree requirements on the date we met. The form is then available to the student and me for future consultation. This was a simple move, but it has eliminated much doubt and confusion. I have adopted policies designed to get the students into my office as early in the process as possible, so that we can get them on a good track towards timely completion of the degree. When I first took this job I encountered several students who had misinformation about where they were with regards to completing the major or minor, and what was required of them. I think my efforts to reach the students sooner, and have a definite record of what we discussed, have paid off because it has been several years since I have seen a problem of that sort. I think these efforts have been successful as it has been years since I have had a student come in with a misunderstanding of the status of the major or minor.

Service:

2005-date: I have served as a member of the Undergraduate Committee. In that capacity I have helped develop departmental policies regarding the completion of the major and the minor, helped complete the department's work on the undergraduate assessment program, and have served on the committee to award the department's scholarship funds.

For the past several years I have served as faculty sponsor of the College Republicans, and of the Lacrosse Team. Neither one of these groups calls on me for much work, but from time to time I have been able to assist them with some troublesome issues related to organization and administration, and I enjoy my interaction with them.
